Tree Type - x2 Birch (Betula pendula)

Approx. Diameter at 1.5m - 0.2-0.3m

Approx. Height - 9m

Approx. Crown Spread Diameter - 5m

Location - Front garden Front boundary

Service - Crown Reduction

Work Required - Crown reduce back to previous by removing between 1-1.5m from the height and approximately 0.5m from the sides Raise the lower canopy to approximately 3m above ground level.

Reason - as part of continued maintenance to control and contain overall size of tree, maintain reasonable clearance over pavement

Tree number - T2

Tree type - Birch (Betula pendula)

Approx Height - 3m

Location - Rear garden Right hand boundary

Service - Stake and tie

Work required- install tree stake and tie

Reason - to aid stability

Tree Number - T1

Tree Type - Plum (prunus spp)

Approx. Diameter at 1.5m - 0.3-0.5m

Approx. Height - 10m

Approx. Crown Spread Diameter - 10m

Location - Rear garden Right hand boundary

Service - Crown Reduction

Work Required - Crown reduce back to previous by removing between 1-2m from the all over

Reason - as part of continued maintenance to control and contain overall size of tree

Tree number - T3

Tree type - Western Red Cedar (thuja plicata)

Approx Height - 18m

Location - Rear garden in the middle

Service - Prune

Work required- raise the lower crown to approximately 4m above ground level

Reason - as part of continued maintenance to provide more light and clearance to the garden

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
