G1 Hornbeams. Cut back lateral overhang to .previous points. These trees are maintained as a high hedge and the stems are located in no38 Millfield Lane but, the spread has become leggy side of 36 and is encroaching over drive and beds.

T2. Indian Bean tree (Catalpa) Carry out a crown reduction of 2m to suitable secondary growth. current height is 7m so height after pruning will be approx. 5m and spread is currently 7m so spread will be 5m tip to tip after pruning. Causing shading to beds around base G2. Birch. Group of ornamental birch trees. formative prune into shape by 2m off of height and 1m off spread and has also become leggy. Height is currently 9m so will be 7 after and spread is approx. 4m so will be 3m after pruning. Causing shading on beds around base.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
