**GRANT CONSENT FOR WORKS TO TREE/S UNDER A TREE PRESERVATION ORDER**

Proposal:  
REAR GARDEN: 1 x Lime (T1) - Reduce crown back to previous and most recent reduction points (approx. 1.5m - 2m reduction all round) whilst preserving a suitable amount of reduced furnishing growth to ensure crown continuity and help preserve screen. Thin crown density by approx. 20%. Raise low epicormic growth by approx. 1.25m. Thin remaining epicormic growth in main stem by approx. 20%.

The Council has considered your application dated 05 September 2023 and decided to grant consent subject to the following condition(s):

#### Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).
