NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

REAR GARDEN: 1 x Multi-stemmed Cotoneaster (T1) - Reduce crown height by up to 1m. Reduce lateral and sub lateral growth by up to 1.2m by means of reducing overlong extraneous branches back into main crown structure. Thin crown density by approx. 20%.

Row of Hornbeams (G1) - Reduce crowns by up to approx. 1.5m all round, reducing overhanging branches back from neighbouring property.

1 x Pear (T2) - Thin crown density by 15%. Reduce overlong extraneous back into main crown structure not more than 1m.

1 x Laurel (T3) - Reduce by up to 1.2m to shape and encourage crown density.

1 x Pittosporum (T4) - Trim to tidy, reduce by 0.75cm.

The Council has considered your notification of intended works to trees dated 11 September 2023 and does not wish to object.

Informative(s):

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.

- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
