Proposed Work:

IN GROUNDS (SEE MAP): 5 x Lombardy Poplars (G1) Reduce back to previous cuts, leaving furnishing growth. Taking off 4m from the height and 2m from the lateral branches.  
23 x Maples (G2) - Reduce crowns back to previous cuts, retaining the branches over the avenue driveway, taking off approx. 2.5m.  
1 x Purple Sycamore (T3) Reduce crown back to previous cuts, taking off 3.5m on all aspects.  
1 x dead Birch (T4) - Fell to ground level.

The Council has considered your notification of intended works to trees dated 11 September 2023 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by

the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
