Thank you for your email. We will keep a record of the points you raised therein.

We note, in particular, your comments on noise levels and timing of the demolition works. These are issues we will shortly be discussing with residents and neighbours as part of our upcoming consultation on the Demolition Management Plan for the works. We will send more information out about this consultation in the coming weeks. On the issue of current users of the car parking area, we can confirm that the garages have been unused for well over a decade and therefore there will not be any cars displaced as a result of the demolition.

Please note that the current consultation on the planning application for the demolition of the parking structure is a statutory consultation being undertaken by the Council's planning authority, and so is separate from and independent of our work as developer of the site. Please could you therefore ensure that your comment on the planning application is directed toward them.
