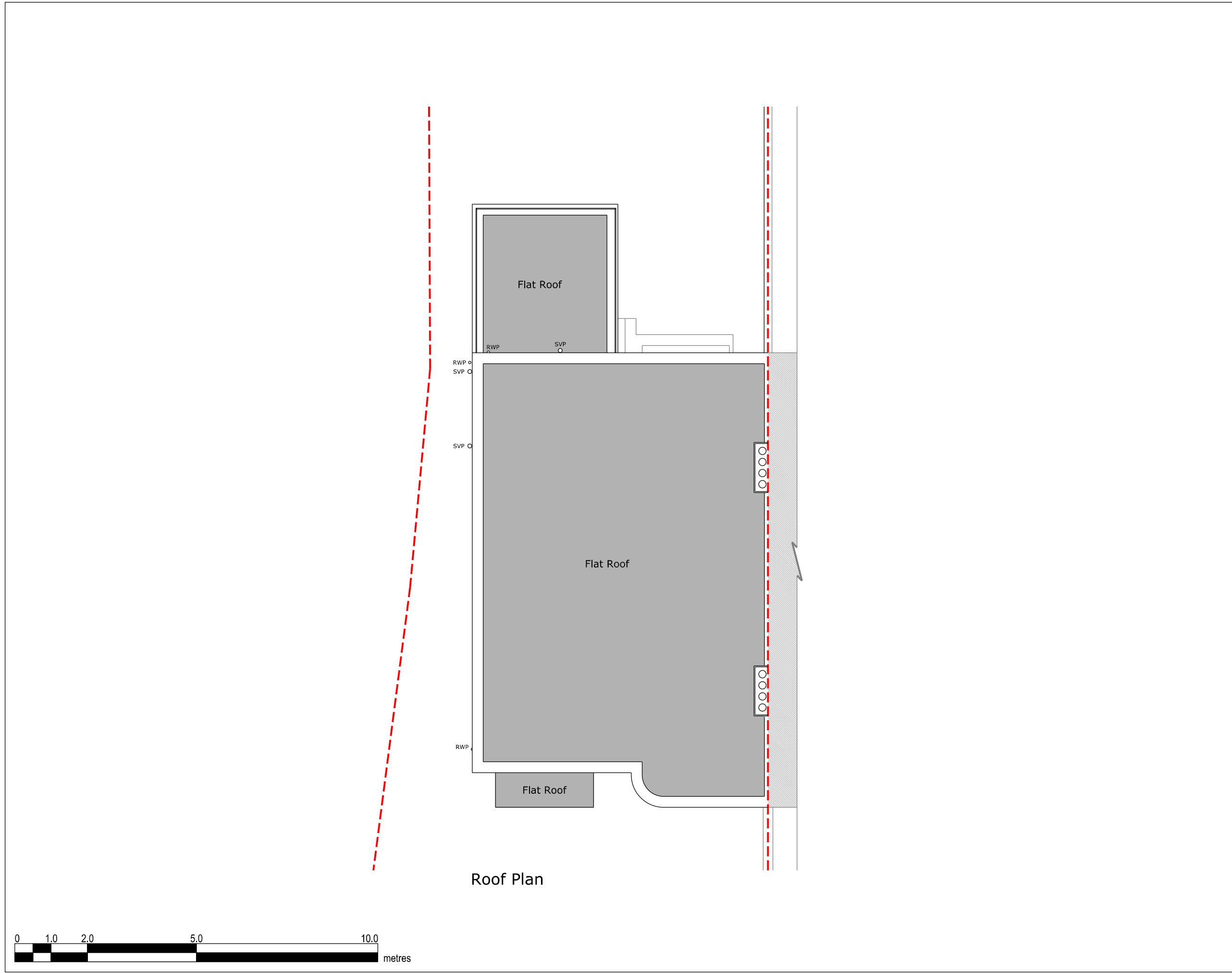




Second Floor Plan

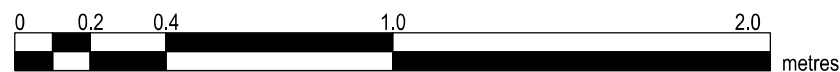
Left Side Elevation

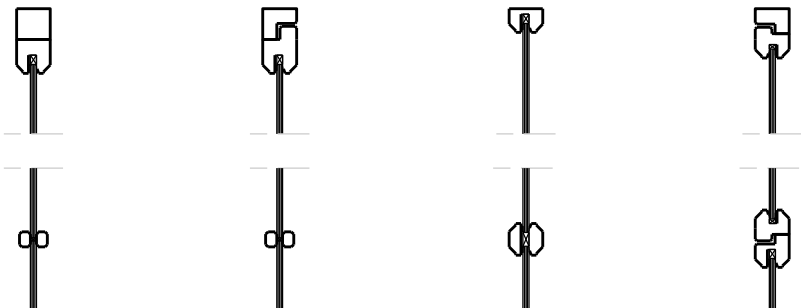
