Fell back garden pear (T1) to allow more light into the garden. Prune the tree of heaven (T2) to remove branches growing over the roof and reduce lower branches back to growth points near to boundary to prevent damage to building and the tree.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
