## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Tree number - T1

Tree type - Plum (prunus spp)

Approx Height - 6m

Location - Front garden Front boundary in the middle

Service - prune

Work required- crown clean removing any major deadwood of more than 40mm in diameter, rubbing or crossing branches and epicormic growth

Reason - as per clients wishes

Tree number - T2

Tree type - Goat Willow (Salix caprea)

Approx Height - 12m

Location - Front garden left hand boundary beside building

Service - Prune

Work required- prune away from buildings to provide approximately 2m clearance, remove major deadwood of more than 50mm in diameter and greater than 0.5m in length, remove the x2 lowest branches

Reason - as per clients wishes

Tree number - T3

Tree type - Pear (Pyrus spp)

Approx Height - 9m

Location - Rear garden left hand boundary

Service - Prune

Work required- crown clean removing any major deadwood of more than 40mm in diameter, rubbing or crossing branches and epicormic growth

Reason - as per clients wishes

Tree number - T4

Tree type - Apple (malus spp)

Approx Height - 12m

Location - Rear garden Right hand boundary near Rear boundary

Service - Prune

Work required- cut away the tree (various self set tree species) along the rear which are encroaching onto the Apple tree to provide minimum of 1m clearance, thin out crown by approximately 20%, remove major deadwood of more than 50mm in diameter and greater than 0.5m in length

Reason - as per clients wishes to provide separation between the wild growth and the Apple tree, provide more light to the garden and remove potential hazards

Tree number - G1 and G2

Tree type - Laurel (prunus laurocerasus)

Approx Height - 4-5m

Location - Rear garden Rear boundary and Right hand boundary

Service - Prune

Work required-

G1= reduce height by removing approximately 1m

G2= reduce height by removing approximate 2m

So both hedges are of the same height at approximately 3m

Reason - as per clients wishes to tidy appearance

Tree Number - T5

Tree Type - Sycamore (Acer pseudoplatanus)

Approx. Diameter at 1.5m - 40cm

Approx. Height - 16m

Approx. Crown Spread Diameter - 10m

Location - Rear garden, centre

Service - Crown Reduction

Work Required - Reduce crown by around 3m height and 1.5m spread, pruning to suitable growth points.

Reason - To maintain clearance from building while keeping good form, As part of regular maintenance to retain best compact form.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

e.g. Oak (T3) – Whole crown reduction to 12m above ground level, to provide sufficient clearance to property.

### Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
