Why is it necessary to demolish all or part of the building(s) and/or structure(s)?

The existing windows are now 30 years old and a number of the double glazed units have blown. The existing curtain walling system used have aged and requires repair/component replacement in a number of locations.

Replacement of the conservatory roof structure and the proposed extensions to the flanks of the Studio require the existing roof structure and side doors to be removed and the lowering of the side light window sills.

The existing Domed and Pyramidal rooflights over stair and study respectively leak consistently and are proposed to be replaced with new flat, structural glass rooflights.
