T1 Yucca rear Leaning tree and oversized for the location. Fell to ground level and treat stump to prevent regrowth.
T2 Cypress x3 rear To help improve light into area below. Suggest: Reduce back to previous reduction height approx. 2-3m, trim back on garden side by 1-2m, remove x1 broken branch across garden.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

T3 Cypress x3 rear left Smaller row of trees on left boundary. Reduce back to previous height approx. 2m trim back on garden side by 1m to

help improve light into garden.
