- 1.0 Norway Maple- Reduce back to former reduction points and trim lower growth to give 5m clearance over the path.
- 2.0 Ash Reduce back to former reduction points and trim lower growth to give 5m clearance over the path.
- 3.0 Lime- Reduce back to former reduction points and trim lower growth to give 5m clearance over the path.
- 4.0 Hornbeam- Reduce back to former reduction points.
- 6.0 Variegated Maple -Reduce back to former reduction points and trim lower growth to give 5m clearance over the path.
- 7.0 Hornbeam- Reduce back to former reduction points.
- 8.0 Ash Reduce back to former reduction points and trim lower growth to give 5m clearance over the path.

  - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - $\circ~$  marking all trees on the plan, but only numbering those to which you want to carry out work
  - $\circ\;$  showing the approximate distance between the application tree(s) and buildings
  - $\circ\;$  adding other relevant features on the site (e.g. greenhouse, paths)
