Tree Type - x2 Sycamore (Acer psuedoplatanus) Approx. Diameter at 1.5m - 0.5-1m Approx. Height - 18-20m Approx. Crown Spread Diameter - 15m Front garden in the middle Service - Crown Reduction Work Req- Crown reduce by removing between 2-3m from the height and between 2-3m from the sides Reason - to control and contain overall size of tree Tree Number - T1 Tree Type - Cherry (prunus spp) Approx. Diameter at 1.5m - 0.2-0.5m Approx. Height - 7m Approx. Crown Spread Diameter - 7m Front garden in the middle Service - Crown Reduction Work Req- Crown reduce back to previous by removing between 1-1.5m from the height and between 1-1.5m from the sides Reason - as part of continued maintenance to control and contain overall size of tree Tree Type - Crab Apple (malus sylvestris) Approx. Diameter at 1.5m - 0.2-0.5m Approx. Height - 6m Approx. Crown Spread Diameter - 6m Front garden in the middle near main building Service - Crown Reduction Work Req- Crown reduce back to previous by removing between 0.5-1m from the height and between 0.5-1m from the sides Reason - as part of continued maintenance to control and contain overall size of tree Tree type - Cypress species (Chamaecyparis spp.) Approx Height - 8m Front garden along front side of main building Service - Prune Work req- trim all over back to previous by removing approximately 0.1-0.2m Reason - as part of continued maintenance to control and contain overall size of tree T3 Tree type - Lime (Tilia cordata) Approx Height - 20m Front garden Front boundary left hand side Service - Prune Work reg- remove the lower cluster of established epicormic growth (the growth growing into the boundary hedge, raise the remaining lower crown to approximately 4m providing a minimum 1m clearance from buildings Reason - to avoid tree misshaping hedge and to provide clear over road, path and buildings Tree type - group of Leyland Cypress (X cupressoncyparis leylandii) forming hedge Approx Height - 12m neighbours trees, overhangs clients left hand boundary, over access road to rear parking area Service - Prune Work req- cut back the overhang on clients side ONLY as close back to the fence line as possible whilst maintaining green growth Reason - as part of continued maintenance Tree Type - London Plane (platanus x hispanica) Approx.  - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
