several over extended extraneous branches which protrude vertically, back into main crown structure approximately 1.25m to preserve the trees compact natural crown line. General maintenance.	
T2: Mature Pear: Approximately 9.00m: (left hand boundary): Thin crown density throughout by 20%-25%. Remove dead wood. Reduce
