All tree references relate to supplied tree location plan.

Rear communal area - Tree 647 - London Plane. WORKS: Reduce canopy to previous reduction points (approx 2m). REASON: Cyclic management and risk mitigation works. The tree is located very close to a boundary retaining wall separating the ground level it is in from the lower ground level of the street and the wall has started to crack in multiple locations close to the tree.

Rear communal area - Tree gi.n1 - Cordyline. WORKS: Fell to ground level. REASON: Is poorly located, hard against external fabric of building.

Rear communal area - Tree 648 - Cockspur Thorn. WORKS: raise lower canopy to 2.5m. REASON: General/cyclic arboricultural management.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:

  - $\circ\;$  showing the approximate distance between the application tree(s) and buildings
  - $\circ\;$  adding other relevant features on the site (e.g. greenhouse, paths)
