The development would only constitute permitted development if the materials used in any exterior work to the roof extension, subject to the grant of this certificate, shall be of similar appearance to those used in the construction of the exterior of the existing dwelling house, in accordance with Condition B.2 of

the Town & Country Planning (General Permitted Development) Order 2015.

The development, subject to the grant of this certificate, would only constitute permitted development where the edge of the enlargement closest to the eaves of the origional roof shall, so far as practicable, be not less than 20 cm from the eaves of the origional roof, in accordance with Condition B.2 of the Town & Country Planning (General Permitted Development) Order 2015.
