- Large cavity in Main stem
- · To reduce the crown to previous reduction points
- To thin the crown density by 30%

T2: Lime

· To reduce to previous reduction points whilst preserving a suitable amount of furnishing growth to ensure crown continuity

T3: Quercus ilex

To thin the crown density by 30%

T4: Twin Stem Sycamore

- · To reduce the crown to previous reduction points
- To thin the crown density by 30% retaining lower furnishing growth to preserve screening

T5: Ash

To thin the crown density by 20%

T6: Sycamore

- To reduce the crown to previous reduction points
- To thin the crown density by 30% retaining lower furnishing growth to preserve screening

T7: Ash

- · To reduce the crown to previous reduction points
- To thin the crown density by 30% retaining lower furnishing growth to preserve screening

H1: Conifer Hedge

• To reduce by up to 2.4m in height and shear the face

 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
