# Identification of Tree(s) and Description of Works

T11. beech tree. Tree currently has asymmetric form due to previous tree cover and low branch tips approximately 2/3 m from ground level. we would like to reduce the tree by up to 2m to create a more balanced crown outline and resulting in a slight weight reduction on limbs that are petruding most, also, lifting crown to a height of 4m from ground level to keep limbs away from obstructions.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
