Tree ca.n4 - Sycamore in rear garden. WORKS: Repollard to 6-7m. Sever Ivy to 1.5m. REASON: Risk mitigation/Cyclic maintenenance (Tree is a historically managed pollard. Large elliptic cavity open to South-East. Screwdriver was inserted 300mm of 450mm stem diameter at point. Brown frass visible in voided cross section, with remaining exposed wood in varying stages of decay, stem is attempting to rams horn either side. Decay section extends 3m+ into primary West and SOuth-East branches where exposed wood has visibly advanced decay and moderate/poor callus development. Ivy is obstructing assessment of higher parts.)

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
