Tree Number - G1 Tree Type - Silver birch x2 (dead) Approx Height - 10m Approx Spread - 6m Location - See map Service - Fell Work required - Fell as close to tree's current ground level as possible and leave the stump in the ground. Reason - dead tree. Tree Number - T1 Tree Type - Ash Approx. Height - 13m Location - see map Work Required - Crown clean (removing dead, rubbing and significantly damaged branches) Reason - as part of continued maintenance Tree Number - T2 Tree Type -Crab Apple (malus sp) Approx. Height - 4m Location - see map Service - Crown thinning Work Required - crown thin by approximately 30%. Reason - as per clients wishes Tree Number - G2 Tree Type - Leylandii & Bay Approx. Height - 9m Location - see map Service - Reduce height Work Required - reduce height by approximately 2-2.5m and trim allround as hard as possible whilst retaining a green screen Reason - as part of continued maintenance

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\;$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
