T1 - ash tree (15m) - reduce crown over roadside by approximately 4m and balance crown.

Reason for work- the tree is very unbalanced possibly due to poor pruning in the past. Local residents are concerned about the safety of the tree as it is unbalanced.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
