Description of Proposed Works

Please describe the proposals to alter, extend or demolish the listed building(s)

We are proposing to replace the existing concrete render on the front elevation of the building. The existing render has started to blister and fail (and appears to have been patched a number of times under previous ownership). The new render will have the same appearance as the existing render, preserving the visual finish to window sills, jams, heads and coping stones to the same protrusion. Although the repair will be 'like for like' in appearance, we are intending to use a lime mortar rather than concrete, being more sensitive to the listed building. Specifically, we will be using a Diathonite Evolution lime-cork insulating render system with a vapour permeable paint. This has been recommended by Eco-Renovation UK.

The existing render does have ashlar render effects (i.e. lines in the render) that are poorly and inconsistently applied. We may not replace these.
