FRONT GARDEN: 1 x Lime (*Tilia* spp) (T1) - Reduce all round to previous reduction points approx. 2m.  
1 x Lime (*Tilia* spp) (T2) - Reduce all round to previous reduction points approx. 2m.  
1 x Cypress (T4) - Trim all round, in accordance with marked photo.

The Council has considered your application dated 09 October 2023 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.
