Proposal:  
REAR GARDEN: 1 x Ash (T1) - Crown reduce height and spread back to the previous reduction points (approx. 3.5m - 4m height and 2.5m - 3m spread) leaving small furnishing growth where possible. Reduce extremities of branches growing towards house to give a clearance of 1.5m - 2m.

The Council has considered your application dated 11 October 2023 and decided to grant consent subject to the following condition(s):

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.
