Reduce birch (T1) height by 3.5m. Reduce remaining crown back to previous cuts (upto 1m off) to allow more light into building and garden.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
