Poplar Tree (T1) - Tree measures around 9/10metres high. Pollard to previous points(2-2.5metres) as part of maintenance.

Poplar Tree (T2) - Tree measures around 9/10metres high. Pollard to previous points(2-2.5metres) as part of maintenance.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
