Located in front garden:

Copper Beech T1 (18M high, 950mm dia.) - Reduce the crown of the tree overall back to the most recent points of reduction and by up to 2 metres. Last done in January 2020.

Reason: Cyclical maintenance of a large tree located in close proximity to the property.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
