1) Replace all four windows of Flat 7, 2nd floor rear flat, 73 Belsize Park Gardens, with double glazed replicas of the existing windows. These windows will be replaced by replica wooden frames so as to maintain appearance. The glass will be double glazed, but otherwise retain the same appearance as the existing windows. There are three transparent windows and one frosted window, which will be replicated in the new windows. None of these widows face directly out to the road - two are at the back of the building and two are along the side of building.

2) Replace existing short horizontal section of waste water pipe from Flat 7 with new double socket access branch and pipe, connecting into the existing vertical waste water pipe running down side of 73 Belsize Park Gardens. This work amounts to a few centimeters of new pipe on the external wall of the property and being inserted into an existing vertical waste pipe.
