Ewan,

We have responded on line to your consultee letter referred to in your email below in respect of planning permission and listed building consent for refurbishment works at 9 Provost Road. Generally the proposals are welcomed since they are restrained and will safeguard the future of this listed building.

However, we do object to the fixed solid panel above the new timber door to the street-facing door of the infill side extension. This has the effect of drawing attention to the interruption of the open spaces between the houses and detracting from the reason why they are listed.

Paragraph 5.6 of the Heritage Appraisal refers to the appearance of the timber door being similar in appearance to 15 and 16 Provost Road. This may be a mistake and perhaps refers to 14 and 15 Provost Road. If this is the case it is a cause for concern because the recently installed solid timber panel clearly harms the rhythm of the open spaces between the houses.

Below are photographs showing the panel between nos.14 and 15, and by way of contrast the see-through vertical metal security fence between Nos. 15 and 16. There is also a photograph of the space between Nos. 10 and 11 which both have side infill extensions which are almost invisible when viewed from the street. These should be the example that No. 9 should follow.
