T1: Pine: Approximately 8.00m: Reduce crown by approximately 1.00m all round, ensuring retention of strong viable foliage and growth points, reduce back to clear neighbouring building as is practicable while preserving viable foliage. Remove major dead wood throughout crown.General maintenance. Control encroachment.
