## Proposed Work:

FRONT GARDEN: 1 x Plum (Prunus spp) (T1) - Crown clean removing any rubbing or crossing branches and epicormic growth.

1 x Goat Willow (Salix caprea) (T2) - Prune away from buildings to provide approx. 2m clearance. Remove the x 2 lowest branches.

REAR GARDEN: 1 x Pear (Pryrus spp) (T3) - Crown clean removing any rubbing or crossing branches and epicormic growth.

- 1 x Apple (malus spp) (T4) Prune to provide minimum of 1m clearance, thin out crown by approx. 20%.
- 1 x Laurel hedge (Prunus laurocerasus) (G1) Reduce height by removing approx. 1m.
- 1 x Laurel hedge (Prunus laurocerasus) (G2) Reduce height by removing approx. 2m.
- 1 x Sycamore (Acer pseudoplatanus) (T5) Reduce crown by around 3m height and 1.5m spread, pruning to suitable growth points to maintain clearance from building and compact form.

The Council has considered your notification of intended works to trees dated 11 October 2023 and does not wish to object.
