(T1) Princess Tree - situated in the rear garden of number 82. The tree is overhanging the roof/skylights of the property to the rear and is touching the building to the left (number 80). It has also lost some small branches to the rear due to becoming too long and overextended. Proposing to reduce crown by 3-4m in order to maintain tree in this location.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
