T21 - Platanus x hispanica (London Plane):

R00 - Reduce crown by specified extent - to previous reduction points to continue established management and manage risk of harm through branch failure.

T23 - Cotoneaster sp. (Tree Cotoneaster):

LPD - Lift low canopy, pedestrian clearance - to 3.5 m over footpath.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
