W1 - Ground floor bay window






W1.2 - Fixed panel 640


W2 - First floor window




OPENABLE CASEMENT ORIZONTAL SECTION






TWO CASEMENTS CONNECTION ORIZONTAL SECTION




FIXED CASEMENT ORIZONTAL AND VERTICAL SECTION
