STATUTORY DECLARATION OF SONIA MUHOI IN THE MATTER OF REEL TIME ADULT GAMING CENTRE, 1-3 EUSTON ROAD, NW1 2SA

I, Sonia Muhoi of 4 Cavendish Square, London, England, W1G OPG, do solemnly and sincerely declare as follows:

- 1. I am an Area Manager employed by Family Leisure Holdings Limited of 4 Cavendish Square, London, W1G OPG.
- 2. I commenced my employment with Family Leisure Holdings Limited on 22 October 2005.
- 3. I was initially employed as a Customer Service Assistant, then as a Manager and latterly as an Area Manager.
- 4. Family Leisure Limited is an independent operator of Adult Gaming Centres which operates sites in King's Cross (1-3 Euston Road) Tooting, Victoria and 2 sites within Soho, both on Wardour Street.
- 5. I have been aware of the operating hours of all sites since I started work with Family Leisure Holdings Limited in 2005 and can confirm that the Adult Gaming Centre at 1-3 Euston Road has at all times since 2005 traded until 0200hours or later.
- 6. In 2019, Family Leisure Holdings Limited was bought out by a new management team and a great deal of paperwork was lost following the acquisition as the company moved to online documentation.
- 7. I have been able to find however the following:
 - (a) A Family Leisure manager's rota for week commencing 26 October 2015, which clearly shows that the managers at King's Cross were on shift daily until 0230.
 - (b) A Family Leisure manager's rota for week commencing 14 August 2017 which confirms exactly the same, i.e. the manager's at King's Cross were on rota daily until 0230hours.
 - (c) A Family Leisure Holdings Limited hourly floor check dated 6 July 2017 which shows the final floor check at 0200hours.
 - (d) A Family Leisure Holdings Limited hourly floor check for King's Cross dated 30 April 2017 which shows the final floor check at 0200hours.
- 8. I can confirm that I have not been able to find any earlier written documentation, but I can confirm that since I have commenced work with Family Leisure Holdings Limited, the King's Cross Adult Gaming Centre has always operated until at least 0200hours. The Management rota and hourly floor check will have been the same prior to 2015.
- 9. The premises have an Adult Gaming Centre Licence issued under the Gambling Act 2005, licence reference CAM-LIC/079 issued by Camden Council.
