In the main room for example the built in cupboards are planned to be removed to provide more space, but any cornicing along the top will be replaced to maintain the room's finishes and character.

Certain elements may need to be moved/altered but everywhere possible they will be retained and reinstated to allow for the original architectural elements to remain.
