				I ask that you please reject application 2023/3285/P in its entirety.
				3-7 Delancey Street (The Forge) was purpose built as a concert hall, but poor materials and a lack of adequate sound insulation means sound can be heard during operating hours, outside the venue and in my home which is on Arlington Road.
				My bedroom is on the Arlington Road side of the house and during some concerts at The Forge, I can feel base vibrations coming from the venue whilst I'm trying to get to sleep at night. Whilst music and whole lyrics from songs being sung in the venue can be heard in bedrooms on the Delancey Passage side of the flat.
				I have 38 vulnerable neighbours at 88 Arlington Road who have issues with alcohol and drug addiction as well as low level mental ill health. It is not fair that on top of these issues that they too get disturbed sleep (like we do) from the sound coming from the venue, as they too have bedrooms backing onto the side of the venue on Delancey Passage.
				Camden's environmental team knows about the problems, has been called on numerous occasions and earlier this year, fought against the venue extending its licensing hours along with the police and local residents.
				The police were particularly worried about the venues customers leaving the venue late at night in a drunk and disorderly fashion. As predicted by them, there are currently noise problems with people leaving the venue and this would be even worse for local residents if the venue were allowed to open later, playing music until 3am in the morning and then turfing 400 drunk people out into a residential street to make their way home.
				The venue has started to book 2024 with 58 live bookings from 23/11/23 - 14/12/24 so far, and will no doubt fill the gaps with other live performances as the year progresses.
				The business does not need this planning application approved to continue their business of providing entertainment in the form of bands and cabaret acts as well as serving drinks and food to their customers.
				If approved, this planning application will allow the venue to turn into a club after the live acts, similar to what The Jazz Cafe do, with live acts finishing around 11pm and then more customers arriving for a club night until 3am.
				Camden already has many late night establishments offering live and then recorded music until 3am. We do not need or want one more in a residential street where they will affect everyones mental health due to sleep deprivation.
				Camden Council has a duty of care to all of their residents and I therefore ask again that you please reject this application in its entirety.
