Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1- Lime tree - We would like to carry out crown reduction to previous pruning points (1-2 metres) and clear epicormic growth around the trunk up to crown break.

T2 & T3 - Norway Maple - Reduce crown spread by 1-2 metres and crown thinning to allow light getting through.

T4 - Pittosporum - Reduce height by 1.5 to 2 metres and trim all around.

T5,T6, T7, T8 - Holm Oak - they are kept as shrubs around 3-4 metres tall (trim and shape)

Laurel hedge - Reduce height by 1 to 1.5 metres and trim to shape.

Beech hedge - Trim to shape

We believe all proposed works considered general maintenance and very important to keep the trees healthy.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
