Reduce and shape crown by approximately 20%, to most recent pruning points, removing lateral growth by approximately 2-3m, to leave a flowing branch line without stumps and the main canopy framework to B.S.3998:13.4.1.

Remove all main dead wood, snags, pegs, and broken branches exceeding 10mm in diameter or 100mm in length, back into live wood and leave canopy clean and tidy, to B.S.3998.

Species: 2 x Ailanthus (Tree of Heaven)

Position: Rear boundary

Reason: Cyclical/outgrowing location

Reduce and shape crowns by approximately 20%, to most recent pruning points, removing lateral growth by approximately 2-3m, to leave a flowing branch line without stumps and the main canopy framework to B.S.3998:13.4.1.

Remove all main dead wood, snags, pegs, and broken branches exceeding 10mm in diameter or 100mm in length, back into live wood and leave canopy clean and tidy, to B.S.3998.
