

# Format & Parameters of assessment:

- 1. Location i.e. Stair Core 1
- 2. Door code i.e. D.G.7

- 4. Door Type Requirements FD30 or FD60

# **Executive Summary**

The purpose of this report is provide a clear statement of condition on all heritage fire doors included within the Phase 3E scope.

The key first takeaway from this report is that all doors except one (potentially two) are in a condition which should allow refurbishment. The extent of refurbishment varies with some doors requiring extensive reparational work to the timber and numerous fire enhancements, with others only requiring minor works, for example, installation of new hot, cold and drop seals.

Regardless of the opportunity to refurbish each door set, Part M is an underlying issue both in terms of effective clear width of a single leaf and force in Newtons required to open each leaf. All doors within the report failed the force push test, many by a large measure. Only a handful of doors met the minimum effective clear width requirement for a single leaf when opened.

Finally, all doors within the report, bar only a handful, are hinged from floor pivot plates. On the recently delivered Phase 2B project, new reproduction heritage fire doors were installed. The designer decided to utilize the pre-existing floor pivot hinge plates. Attaining certification on the door sets has been challenging due to the difficulty of sealing cold and hot passage around the floor pivot plates.

Given the above challenge, the planning submission for the Phase 3E project puts forward a proposal of installing an inner subframe solution which would allow the door leaves to be side hinged and rebated with continuous hot and cold seals around the door frame.
