## Application for Full Planning Permission and Listed Building Consent: Electrical Infrastructure Upgrade, National Hospital for Neurology and Neurosurgery

On behalf of our client, University College London Hospitals NHS Foundation Trust, please find enclosed an application for full planning permission and listed building consent at the National Hospital for Neurology and Neurosurgery, Queen Square, London WC1N 3BG. The description of development is as follows:

'Minor internal and external alterations to basement, ground floor and second floor level associated with wider electrical infrastructure upgrade; including installation of substation and external condenser units'.

The application has been submitted online via the Planning Portal (ref. PP-12294064), and the relevant application fee has been paid under separate cover.

### **Application Site and Proposal**

The NHNN is the UK's largest dedicated neurological and neurosurgical hospital, which has been in operation for circa 160 years. The proposals are associated with a programme of electrical infrastructure upgrades which will provide a long-term solution to existing electrical issues at the hospital, including insufficient electrical capacity, which are currently restricting the operation of the hospital.

The hospital is comprised of multiple interconnected buildings constructed at different times. The current proposals relate specifically to the Chandler Wing and Albany Wing (Grade II Listed). The proposals primarily relate to the basement level with some minor alterations proposed at the ground and second floors of both buildings. The proposals are largely internal and at basement level but also require some minor external alterations at ground and second floor level.

#### **Concluding Remarks**

The application proposals will ensure the continued and safe operation of the NHNN, which is the UK's leading neurological and neurosurgical hospital, and improve patient and staff safety and comfort.
