Tree strd.1 - Leyland Cypress. WORKS INTENDED: Fell to ground level and replant with x1 heavy standard A griseum. REASON: Tree species is unsuitable to allow to grow into mature height - within 4m from single storey extensions. Has been unsympathetically managed historically and has subsequently developed tight branch unions. Early Seiridium infection also observed.
