Please refer to tree location plan supplied for referred tree locations.

Tree Ref: blyrd.1 - London Plane. WORKS PROPOSED: 2-3m canopy reduction in height and in all cardinal directions to appropriate side growth. Raise lower canopy to 3m. Deadwood. REASON: General arboricultural management and mitigation of multiple complaints from neighbours.

Tree Ref: 888 - Common Lime. WORKS PROPOSED: repollard to previous points. REASON: Cyclic management regime - tree is a low historic pollard.

Tree Ref: br.nn10 - Ash. PROPOSED WORKS: Fell to ground level and poison stump. REASON: Selfset tree is causing adjacent retaining boundary wall to break from direct pressure.

Tree Ref: br.nn11 - Ash. PROPOSED WORKS: Fell to ground level and poison stump. REASON: Selfset tree is poorly located too close to same boundary retaining wall.

Tree Ref: 885 - Sycamore. PROPOSED WORKS: 2m canopy reduction to appropriate side growth. REASON: General arboricultural management

Tree Ref: 886 - Horse Chestnut. PROPOSED WORKS: Reduce canopy to previous reduction points (approx 1-2m). Deadwood. REASON: General arboricultural management.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:

  - $\circ\;$  showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
