The Council has considered your application and decided to **refuse** planning permission for the following reason(s):

Reason(s) for Refusal

- The parasols/jumbrellas by virtue of their size, location, design and materials which add bulk to the building, obscuring the elevation of the upper floors on the front façade, have a detrimental impact on the character and appearance of the host building, and the visual amenity of the existing street scene and the wider public realm. The proposals are thereby considered to be contrary to policy D1 (Design) of Camden's Local Plan 2017.
- 2 The parasols/jumbrellas, by virtue of their size, location, design and materials and prominence from the wider public realm are considered to have a negative impact on the setting of the nearby listed wall enclosing Stables Market and the character

and appearance of the Regent's Canal Conservation Area. The proposals are therefore considered to be contrary to policy D2 (Design) of Camden's Local Plan 2017.
