Holm Oak within 2 metres of both adjacent properties: Remove to ground level.
Slender, semi mature Holm Oak. This tree is too close to the properties in relation to its potential size in maturity. My client and neighbour are worried about issues with their foundations in the future.
The garden and area are surrounded by trees so foliage loss will be minimal.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
