NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

FRONT GARDEN: 1 x Cherry (T1) - Reduce back to previous and most recent reduction points up to approx. 1.5m, reducing overlong extraneous branches back into main crown structure. Thin crown density by approx. 20%.

1 x Bay (T2) - Fell to ground level.

1 x Acer (T3) - Thin crown density by approx. 20%.

1 x Magnolia (S3) - Reduce to approx. 1.5m to shape.

REAR GARDEN: 1 x Bay (T4) - Fell to ground level.

1 x Multi-stemmed Bay (T5) - Reduce to previous and most recent reduction points approx. 2.5m. Trim lateral growth to tidy.

1 x Birch (T6) - Trim low branches up to 30cm to clear gutter.

The Council has considered your notification of intended works to trees dated 06 November 2023 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.

- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
