T1 - Weeping Birch Tree - Trim vertical growing branches back towards the top of the tree by approx 1.5m. Raise the crown to give good clearance over the Road, paving and neighbours garden by approx 3m. Reduce the lateral spread away from neighbours garden by approx 1.5m.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
