Reduce height of plum (T1) by 4m. Remove dead stems of bay (T2) and reduce height by 3m, raise by removing lowest growth. Reduce willow (T3) back to previous cut (3m off), leaving furnishings growth. Thin apply (T4) by removing upright growth, reduce back to previous cuts (2m off). All work is to maintain good health of the trees and to allow more light into the garden.
