G2 - Reduce two Sycamore trees in the neighbours garden (12a Millfield Lane) that overhang the solar panels and roof terrace as detailed in the picture. The larger of the pair is to be pollarded, reducing the height by approximately 4m and the smaller is to be reduced to a framework for future growth, removing all overhang. To manage trees crowns within proximity to surroundings.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
