Given my recent visit to site on 9th August 2023, I can now provide you with a comprehensive quotation for tree pruning at 50 Bloomsbury in WC1B 3QT.

### Quote specification and costing:

#### Tree pruning

- No parking on site so team will have to pay to park nearby.
- Due to access issues team will have to transport waste through house.
- Team to attend site and crown reduce maple tree by approximately 2.4m in height and spread.
- Team to use chainsaws and chipper to process waste.
- Waste to be carried through house.
- All generated green waste to be removed from site to a recognised waste facility.

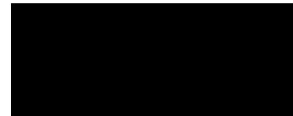
### Additional details:

Please find below additional details relating to this quote:

- Works will be carried out by our NPTC trained arboriculture certified team using rope and harness techniques, chainsaws, chippers and various hand tools where applicable, as per the areas identified within the site plan overleaf
- All work areas will require cordoning off to create a safe working zone prior to works commencing using cones, barriers and warning signs
- Current boundary lines are marked within the fence line. Any areas outside of the marked boundary lines will be classed as additional areas unless agreed prior to commencement
- If trees are subject to a Tree Preservation Order (TPO) or are situated within a Conservation Area, consent will be required from the Local Planning Authority before works can commence. We would make any TPO applications on your behalf as part of the works. Works to neighbouring trees will require the owner's written permission in advance before works can begin
- With any tree or shrub works, Ground Control must ensure that no nesting birds are disturbed under the Wildlife and Countryside Act 1981, Countryside and Rights of Way Act 2000 and the European Habitats Directive 1992/Nesting Birds Directive. The 'Bird Nesting Season' is from March until August inclusive. If any works are requested to be carried out within these months we will perform bird nesting checks prior to the work commencing. If active nests are found, the tree/shrubs must not be worked on and we will inform you of this immediately

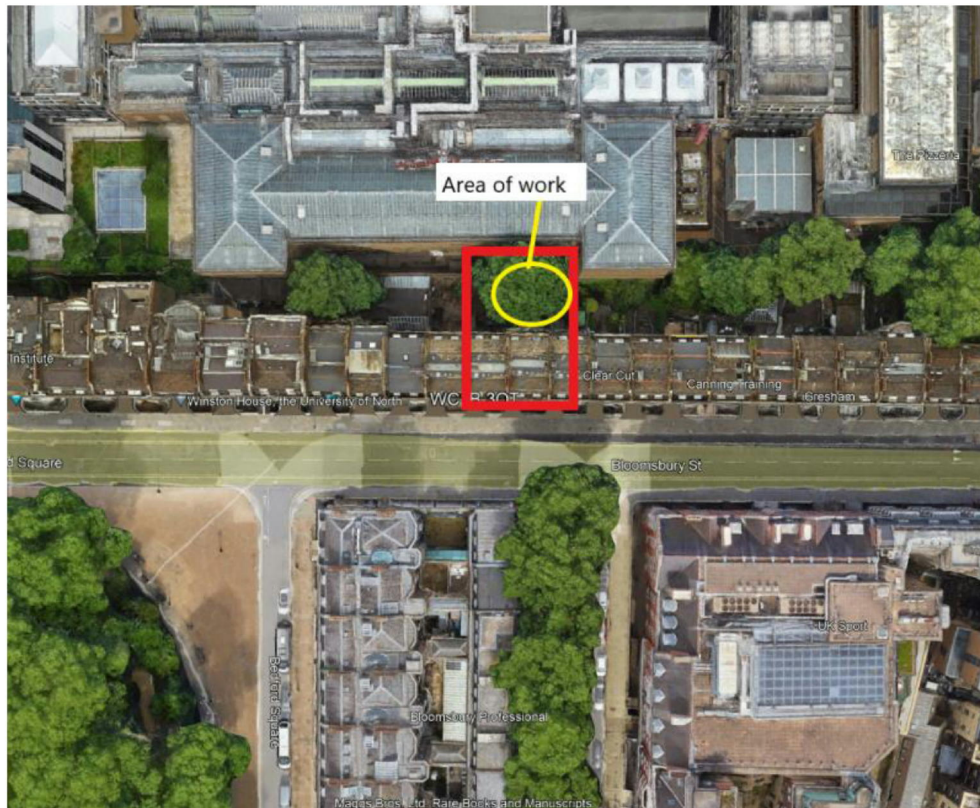
